PRESIDENT'S MESSAGE



In the last few weeks, I've had two members contact me in regards to the correct procedure when the gas has been interrupted to a building.

I reached out to Tom Buckley and below was his response.

Code and long standing gas company policy states that when gas service has been interrupted by the Gas Company or Fire Department, the property owner shall contact a licensed plumber/gasfitter whom shall perform a test for entire structure, obtain a short form permit, and have a WSSC Inspector witness the test. Code References: WSSC 107.8.1; IFGC 406.6.3.

I hope this information is helpful. If you have any questions, you can contact me or your Depot Lead Inspector.

WSSC Commissioners postponed the vote to renew the HomeServe contract. The vote was slated to take place at the March 20th Commissioners Meeting, but after the Pledge of Allegiance, the Commission voted to amend the agenda removing the HomeServe contract renewal. There was no explanation given as to why this item was being removed. Hmm, maybe it had something to do with a little birdie notifying the Commission last minute that HomeServe had acquired CroppMetcalfe.

Jim Mazzullo then drafted a letter to WSSC Commissioners that shared our continued concerns with WSSC's affiliation with HomeServe. The letter was approved by our Board and sent to the Commissioners on March 29th. Copies were also sent to Carla Reid (WSSC General Manager), Monica J. Johnson (WSSC Deputy General Manager for Strategic Partnerships), Crystal Knight-Lee (WSSC Director of Customer Service), Montgomery County Executive Marc Elrich, and Prince George's County Executive Angela D. Alsobrooks.

The next Commissioners meeting is scheduled for April 17th (same day as our general meeting). The HomeServe contract renewal is back on the agenda. HOWEVER, also on the agenda is a closed session taking place for Commissioners "to consult with counsel to obtain legal advice regarding the HomeServe USA Agreement." We will have representation at the Commissioners meeting, and will give an update at our general meeting that night. Maybe we'll have some good news to share.

Our April meeting is being sponsored by M.J. Friedl. Friedl is a new sponsor for us who represents Metrotech video inspection cameras and locating devices. Come to the meeting and check out some equipment, enjoy a free dinner, socialize with friends, and hear what's happening in your industry.
