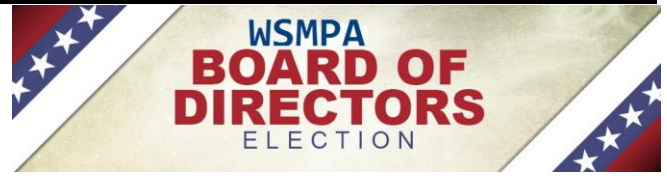
Speaking of which, we will be raffling off a new M12 Milwaukee heated jacket (MSRP \$380.00) at the December 19th meeting.
